The Policyholder is identical to the Insured.

This insurance policy is in force **from 27.02.2026 to 26.02.2036**

Basic insurance

The Insurance is arranged in case of the Insured's statutory liability for injury to another in connection with the Insured's activities or relationships specified in the Insurance Contract.

The Insurance shall also cover liability for damage caused by defects in the product and defects in the work performed, which become apparent after delivery, in connection with the performance of the activity covered by the above-mentioned Insurance Contract.

The basic Insurance is arranged with an insurance indemnity limit of **CZK 20 000 000.**

The above limit of insurance indemnity is the upper limit of Insurer's indemnity from one loss event. The Insurer will provide an insurance indemnity for all loss events occurring during one insurance year up to a maximum of twice the limit of insurance indemnity agreed in the Insurance Contract in aggregate. If the insurance is taken out for a period of less than one insurance year, the Insurer shall provide an insurance indemnity for all loss events occurring during the period of insurance up to a maximum of the limit of the insurance indemnity agreed in the Insurance Contract.

Insurance cover extensions and additional insurance

Additional insurance and extensions of insurance cover shall be arranged with a sublimit of indemnity within the limit of insurance indemnity agreed for the basic insurance, in the case of insurance of liability for damage caused by product defects and defects in the work carried out which become apparent after delivery, or within the sublimit for this Insurance, if agreed. The sublimit is the upper limit of the Insurer's indemnity from one loss event and at the same time in aggregate from all loss events arising from causes occurring during one insurance year, unless otherwise agreed in the Insurance Contract.

Additional insurance of liability for damage to goods taken or to goods or animals used

Additional insurance of liability for damage caused to movable property taken over by the Insured for the purpose of carrying out the ordered activity (e.g. repair, modification, sale, safekeeping, storage or provision of professional assistance) and liability for damage caused to movable property or an animal which the Insured lawfully uses. The additional insurance does not cover damage caused to a motor vehicle used and an animal taken in possession.

Additional insurance does **not cover** liability for damage caused to the motor vehicle taken over if the Insured took it over to carry out the ordered activity on it (e.g. repair), not to carry out the ordered activity with its help (as a means to carry out the ordered activity).

Additional insurance is agreed with a sublimit of **CZK 300 000**.

Territorial scope

The Insurance is arranged with the following territorial scope: the territory of the **Europe**.
